


handled a total of 72,282 toys. Of that total 30,075 toys were collected from



Political Battle of the Marine Corps

Part 1 of 6

Fighting any battle is a hard endeavor, and will require all the resources that a commander can muster and more to win the battle. The United States Marine Corps has fought countless battles in its long history, yet it has never backed down from a fight nor ran from one. Marines are known for their commitment to be the "First to Fight", in the early twentieth century the Army recruiting posters had the slogan, "Join the Army and Learn a Trade". Likewise, the Navy's famous "Join the Navy and See the World" appeared on their posters. As for the Marines during the same period of time a 1907 poster proclaimed "First to Fight" was all that was needed to be said of what it meant being a Marine.

Battles fought and won by the Marine Corps are well known throughout its illustrious history, but there is one that continues, even to this day. This battle is not in a far off battlefield in Afganistan or Fallujah, Iraq. This battle has been fought between the Army, Navy, Air Force, the White House, and in the halls of Congress; as well between the Marine peers in the other military branches. The start of this battle was before November 10, 1775 when Gen. George Washington told the Continental Congress "would not only cost the army time, anxiety and pain, but would also weaken it" concerning Congress' decision to raise two battalions of Continental Marines. After the Marines were established, general opinion of them were that they were "Prima Donna's". This opinion was apparent in the leadership of the Continental Army, because when Gen. Washington in November 30, 1776 was routed by the British in New York and was in full retreat through New Jersey with the British fast behind him, he sent for reinforcements from Philadelphia, itself in dire straits. Philadelphia sent Washington, militiamen, seamen from two frigates, and three companies of Marines. When Washington sent for the relief from Philadelphia, he urged Colonel Cadwalader, his commander at the time to "let me know in the meanwhile if they [Marines] came out resolved to act upon land or meant to confine their service to water only". Marines did turn out at Washington's call, on the 2 December, a Marine detachment of 131 men from the Privateer Hancock held Burlington, New Jersey and a battalion under the command of Major Nicholas did engage the enemy in Princeton, although a small engagement with British forces, with the lose of an officer and four enlisted. The Marines

fought two battles that day and won, the first they over came the physical enemy and they showed that their more than able to come out and fight when called upon, although the third battle goes on.

EOD Techs Passionate About Their Job

AL ASAD, Iraq (Dec. 25, 2006) -- Most Marines try their best to avoid improvised explosive devices, but these hardcharging Marines seek them out.

Explosive ordnance disposal technicians with 2nd EOD Platoon, 1st Marine Logistics Group (Forward), counteract lEDs everyday.

"The great element of this job is I'm able to work tight with my unit," said Sgt. Harry W. Parker, an EOD technician with 2nd Platoon. "We're one team and that is it Cohesion is important, and EOD units consist of small teams for a reason. The Marines said that is a job with no margin for error, trusting each other is vital.

The three Marines in 2nd Platoon said they joined EOD for a challenge.

"I joined EOD to better myself," said Staff Sgt. John Pado, leader of Team 'Chuck Norris', EOD Platoon.

"In this (occupation) you have the skill to minimize a threat to save Marines."

The threats of IEDs are dreadfully real, and not only are these Marines aware of the dangers they face, but it drives them to keep executing their missions.

"The danger is a given factor," said Parker, 34, a Cedar Hill, Texas. "When you go out you have to be in a mind set where you have to be as cautious and know what you are doing."

He said there is never a dull day in the life of an EOD technician.

"It's an adventure beyond what I could imagine," said Pado, a native of Toledo, Ohio. "Because of the experience, it has opened up numerous opportunities for me to become a better Marine.'

The Marines remain enthusiastic about their job despite their high deployment rate. Currently, they spend six months away from their family every year.

Pado said the job takes a lot of self-discipline and family support to exercise caution during day-to-day operations counteracting lEDs.

"You have to have the love for the job," said Sgt. Scan D. Pinckney, 30, an EOD technician with 2nd Platoon and a native of Jeffersonville, Ind. "The explosions, gathering up wire, it takes a lot of patience."

PREFACE

The guidance of this Uniform Code is presented as a standard to establish uniformity and define appropriate wear of the Marine Corps League Uniforms. The word "uniform" itself is defined as "(1) Always the same, as in character or degree; unvarying (2) Conforming to one principle, standard, or rule; consistent". Because many features about these uniforms clearly resemble United States Marine Corps uniforms, it is very likely that an unmindful public may see that we are the Marines; and when today's Marines see us wearing uniforms that are a likeness to their own, they will be seeing us as one of their own. Our appearance reflects upon the Marine Corps and Marines everywhere, and we should ever be aware of that responsibility. Uniforms prescribed in this Uniform Code are considered appropriate to preserve the respect and dignity of the Marine Corps League and the United States Marine Corps.

IV. SHOULDER PATCHES

- A. Shoulder patches are worn on the UNDRESS Uniform and the CEREMONIAL Uniform ONLY.
- B. The Marine Corps League shoulder patch will be worn on the left sleeve, centered on the sleeve and 1-1/2" below the shoulder seam.
- C. The United States flag patch (2"x 3 1/2") will be worn on the right sleeve, centered on the sleeve and 1-1/2" below the shoulder seam. The United States flag patch will have a white border, and will have the Field of Blue to the right (to the wearer's front).
- D. If a member of the Military Order of Devil Dogs, the MODD patch will be worn in place of the United States flag patch, centered on the sleeve and one 1-1/2" below the shoulder seam. No Service or Unit patches are to be worn on the Marine Corps League Uniform.

V. MARINE CORPS LEAGUE COVERS

A. All members of the Marine Corps League are authorized the Red cover. Members elected to National office, or appointed to National Staff/Committees are authorized to wear Gold covers. The National Commandant will wear a White cover. Members elected to, or appointed on the Department (State) level are authorized to wear Red with Gold crown covers.

- B. The Past National Commandants are authorized to wear a Gold with White crown cover. Past National Division Vice Commandants, Past National Executive Directors, Past National Directors of Young Marines, Past Chief Devil Dogs, Past Department Commandants, Past Pack Leaders, and Past Detachment Commandants, with the years displayed for holding that office, are the only members who are authorized to wear their respective cover after their tour of duty is completed. All other members will revert back to the appropriate cover for their current elected or appointed office, removing their prior officer identification strips.
- C. The only insignia authorized for wear on Marine Corps League covers is the solid gold Marine Corps Emblem on the left side. The Devil Dog patch, if authorized, will be worn up front on the right side of the cover. The identification strips, i.e., Department or Detachment strip, or embroidering, will be centered on the right side. If the "LIFE" strip is worn, it will be to the rear of the right side. The "LIFE MEMBER" strip will be worn the same as the identification strips are worn, and should be worn above other strips. NO DIVISION PINS OR OTHER PINS/ORNAMENTS ARE AUTHORIZED ON MARINE CORPS LEAGUE COVERS.

VI. SPECIAL UNIFORM AUTHORIZATION

The standard Marine Corps League cover is the minimum uniform item worn by members to be considered "in uniform". Although clothing and apparel worn with the standard cover may or may not have a Marine Corps or Marine Corps League theme, and may be appropriate attire, that attire is not a uniform of the League. ONLY those uniforms that are outlined under "UNIFORM - MALE"; "UNIFORM - FEMALE": "ASSOCIATE MEMBER UNIFORM"; and "CEREMONIAL UNIFORM" are approved uniforms of the Marine Corps League. No variation(s) of the prescribed uniforms are authorized. In case of inclement weather (rain, snow, sleet, or cold), the local detachment or department commandants may authorize appropriate outer wear to be worn over the Marine Corps League Uniform. Proposed changes to the Uniform Code must be submitted through the Bylaws and Administrative Procedures amendment process.

A Marine should be sworn to the patient endurance of hardships, like the ancient knights; and it is not the least of these necessary hardships to have to serve with sailors.
