Memorial Day

Memorial Day is on the 26th. of May, at 1000 hours. The ceremony is held at the Idaho State Veterans Cemetery.

Memorial Day, a day set aside to remember and honor our fallen hero's. The day was first observed 5 May 1866 in Waterloo, New York and is credited as the birthplace of the holiday. After a proclamation by Gen. John A Logan, the National Commander of the Grand Army of the Republic, a veterans organization, General Order No. 11. The proclamation called for the laying of flowers and wreaths of the fallen Union and Confederate Soldiers graves at Arlington National Cemetery. Decoration Day as it was called was first named, was observed on the 30th of May, because it had no ties to any Civil War battles. The first observation was held on 30 May 1868. Decoration day was officially adopted by the State of New York in 1873 and by 1890 all of the Northern States observed it. Not until the end of World War 1 did the Southern State adopted it, to honor those killed in action in all of our wars. Memorial Day was an alternate name to Decoration Day and was first used in 1882. After World War 2 the Memorial Day name was more prevalent and became official by Federal Law in 1967. On June 28, 1968 The United States Congress passed the Uniform Holiday Bill, which moved the holiday from May 30th to the last Monday in May. The Law took effect on the federal level in 1971 and was soon followed by the States.

History of Marine Corps Divisions

History of 3rd. Marine Division

Immediately after its activation and still in its organizational state, the Division began intensive combat training, including new tactics and maneuvers based on lessons learned in Ko-

rean War. During the remaining part of 1952 elements of the Division participated in numerous exercises and training problems, including vertical envelopment (helicopter landing), air-borne operations and attack, and defense against atomic weapons and missiles.

In August 1953 the Battalion arrived in Japan to support the 1st Marine Division in the defense of the Far Eastern area. In March 1956 the Battalion moved to Okinawa and remained there in a readiness posture until 1965.

On 6 May 1965, the 3d Marine Division opened the Marine Compound at the Danang Air Base, Vietnam. The Battalion operated in Vietnam from this time participating in operations from Danang to Phi Bai to Quang Tri/Dong Ha Combat Base. For Meritorious Service in the Republic of Vietnam during the period 1 January – 30 September 1968 the Battalion was awarded the Meritorious Unit Commendation. The Battalion departed Vietnam in November 1969 and moved to Camp Courtney, Okinawa, where it is presently located.

Missing in America

A program started by the State of Idaho to find the cremated remains of those Veterans and their spouses and properly inter their remains at the Idaho State Veterans Cemetery. The following is the statutes that govern the process. At the pre-convention this topic was brought up and it was requested and suggested that we help find our Missing in America.

Idaho Statutes

TITLE 54

TREASURE VALLEY DETACHMENT MARINE CORPS LEAGUE

DETACHMENT NO. 878

PROFESSIONS, VOCATIONS, AND BUSINESSES CHAPTER 11

MORTICIANS, FUNERAL DIRECTORS AND EMBALMERS

54-1144. UNCLAIMED REMAINS OF VETERANS. (1) The division of veterans services may assume control over the cremated remains of a deceased person if:

- (a) The decedent's remains have not been disposed of pursuant to a prearranged funeral plan as set forth in section 54-1139, Idaho Code;
- (b) The persons vested with the right to control the disposition of the remains of a deceased person pursuant to section 54-1142, Idaho Code, have not made final arrangements for the disposition of the remains within one (1) Year following the deceased person's death or have not exercised control over those remains for a period of one (1) year; and
- (c) The division of veterans services certifies that the deceased person is eligible for interment at the state veterans cemetery as an armed forces member pursuant to the rules of the state veterans cemetery.
- (2) An Idaho chapter of a nationally chartered veterans services organization may assume control over the cremated remains of a deceased person if:
- (a) The decedent's remains have not been disposed of pursuant to a prearranged funeral plan as set forth in section 54-1139, Idaho Code;
- (b) The persons vested with the right to control the disposition of the remains of a deceased person pursuant to section 54-1142, Idaho Code, have not made final arrangements for the disposition of the remains within one (1) Year following the deceased person's death or have not exercised control over those remains for a period of one (1) year; and
- (c) The Idaho chapter of a nationally chartered veterans services organization certifies that:

- (i) The deceased person is an armed forces member as defined in the rules of the state veterans cemetery;
- (ii) The Idaho chapter of a nationally chartered veterans services organization shall be solely responsible for the costs of interment, including the application for and receipt of any available governmental benefits.
- (3) There shall be no liability of a funeral establishment, mortuary, cemetery, crematory, or a related entity, a licensed mortician, or licensed funeral director, or any employee or agent thereof who transfers the cremated remains of a deceased person to the division of veterans services or an Idaho chapter of a nationally chartered veterans service organization pursuant to the provisions of this section.
- (4) There shall be no liability of the state of Idaho or any employee or agent thereof related to the transfer of the cremated remains of a deceased person to an Idaho chapter of a nationally chartered veterans services organization or the interment of such remains pursuant to the provisions of this section.
